WHEREAS, it is the intent of the Rolling Hills Community Services District ("District) to adopt a fee schedule for the purpose of conducting District Business;



WHEREAS, after the conclusion of the public hearing, the Board further considered the proposed Master Fee Schedule to be adopted; and


