WHEREAS, a petition has been submitted to the Board of Supervisors of the County of El Dorado proposing the formation of the Springfield Meadows Community Services District, and

WHEREAS, said proposal was approved by the El Dorado County Local Agency Formation Commission on June 28, 1978, by a Resolution of said Commission No. 78-55, and

WHEREAS, the Board of Supervisors has called a hearing on the proposed formation and has given notice of said hearing in accordance with law, and

WHEREAS, at said hearing all persons wishing to speak for or against said district were called to be heard, and that there were no written or oral protests received or offered, and

WHEREAS, the Board of Supervisors of the County of El Dorado has examined the petition for formation of the Springfield Meadows Community Services District, and has determined that said petition complies with the Community Services District Law, and further, finds and determines that one hundred percent (100%) of the registered voters within the proposed district have signed the petition, and

WHEREAS, the Board of Supervisors has determined that all lands described in the petition will be benefitted by the said proposed district, and that said district will be in the public interest and is economically feasible,

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of El Dorado that the boundaries of the proposed Springfield Meadows Community Services District are hereby fixed as described in the petition for formation of said district and as described in Exhibit "A" attached to this Resolution and incorporated herein by this reference, and Resolution No. 205-78 Page 2.

BE IT FURTHER RESOLVED that in accordance with Chapter 2 (commencing with Section 61110) of Division 3 of Title 6 of the Government Code, the Board of Supervisors of the County of El Dorado hereby declares the Springfield Meadows Community Services District duly organized; and

BE IT FURTHER RESOLVED that the name of said district is hereby fixed by the Board of Supervisors as required by law, as the Springfield Meadows Community Services District; and

BE IT FURTHER RESOLVED that the purposes for which the Springfield Meadows Community Services District is formed are as follows:

1. Public recreation as authorized in subdivision (e) of Section 61600 of the Government Code; and

2. Street lighting as authorized in subdivision (f) of Section 61600 of the Government Code; and

3. The opening, widening, extending, straightening, and surfacing, in whole or part of any street in such district, subject to the consent of the governing body of the county or city in which said improvement is to be made as provided in Subdivision (j) of Section 61600 of the Government Code; and

4. The construction and improvement of bridges, culverts, curbs, gutters drains, and works incidental to the purposes specified in Subdivision (j) of the Government Code, subject to the consent of the governing body of the county or city in which said improvement is to be made as provided in Subdivision (k) of Section 61600 of the Government Code.

BE IT FURTHER RESOLVED that the Board of Supervisors as required by law hereby designates the following persons as the members of the Board of Directors of the district:


