a. November 8, 2022 Election - Ballot Measure For Increase of Tax Per Parcel To Provide Funding to Maintain and Improve Essential District Infrastructure and Services and for Other Lawful Purposes of the District – Consideration of Resolution approving ballot measure language to be submitted to the El Dorado County Registrar of Voters for placement on the November 8, 2022 ballot. The draft language includes a proposed tax increase of \$500 per year per parcel within the District, with the possible exception of the parcels located within the Sierramonte neighborhood.
